Did You Know? The recent enactment of the CARES Act brought about some changes to individual charitable giving that we want you to be aware of:

- **For taxpayers who do not itemize their deductions:** The Act allows an above-the-line deduction for contributions of up to \$300. Even if you claim the standard deduction in 2020, in addition, you can write-off up to \$300 in charitable giving.
- **For those who itemize deductions:** The Act has increased deductible income limits for contributions by individual donors. Individuals can deduct up to 100% of their adjusted gross income (AGI) in 2020.

These contribution changes apply to cash contributions in 2020 only. Contributions to donor advised funds and supporting organizations do not qualify. Existing carryover rules of five years still apply for contributions over deductible income limits. Please consult your tax advisor for specific information relative to your tax status and to other CARES Act changes.
